There are 3 Championships.

***National Weekly Championship** (for weekly sanctioned tracks) Best 15 races are scored towards the Championship standings.

***Touring Championships.** Each Region has a minimum \$5000 to win Regional Championship for Touring events.

***Grand Nationals.** Must run a minimum of 15 FASTRAK events to qualify for the Grand Nationals at the end of the year. (If your intention is to run a minimum number of events to qualify for the Grand Nationals you must pay both Touring and Weekly membership for reasons of tracking your races.)

***CAR OWNERS Point system.** Car owners MAY be tracked separately in case of team split during the season. This is for the purpose of qualifying for the Grand Nationals only.
